Board Meeting Update:

Committee met to discuss an issue of an unauthorized shoreline tree cutting and bush removal

Hoffman Beach Parking Lot. Few of the committee members met with the property owner and advised

him that there would be fines filed. Police was also called at the scene of unauthorized work and

report was filed. Legal will be involved for this matter and fines will be addressed to the property

once discussed and approved by the board members.

Summary:

The committee reviewed the key points of the event.

Thomas Wall, Pulkit Desai and Dan Nazzarro met with the property owner and advised him that

would be fines filed. A police report was written.

Pulkit will be contacting legal for a letter to send to the property owner. A copy of the police report will

also be included with the letter the attorney will be sending to the property owner.

A fine was discussed i.e., the legal fees will be the monetary fine.

But, in addition to the monetary fine (that'll be based on the legalities involved and expense), committee members also collectively agreed to charge a physical fine. The physical fine will be that the

property owner must secure a licensed and insured contractor to clean out the remaining portion of the

low water drain channel. The contractor must provide a certificate of insurance naming the I PPOA

second insured.

And in the case of the legal letter being ignored by the property owner then suggestions ranged from

sending a second letter with a revised charge due to additional legal fees to placing a lien on the

property. This will be discussed further with the committee if needed.
