As a Board, we will make every effort to make sure that members who come to the meetings have both the opportunity to hear about what the Board is accomplishing, and in turn have their concerns and questions heard.

First and foremost, the members of the board are your neighbors volunteering their time. We are not compensated for the time we spend away from our families, working to make our lake community a better place for everyone. We are comprised of teachers, paraprofessionals, IT specialists, college administrators, accounting and HR, RNs, mechanics and engineers. ## PRESIDENT'S MESSAGE

The board felt it was important to improve its outreach to the community as well as looking at the suggestion to have some sort of hardship fund. Both projects will require a great deal of time and volunteers to work to make them happen. To simply have an idea without a solid plan of execution is a recipe for further confusion, accusations, rumors and frustration.

After careful consideration, the Board has determined to assess for 2017 and 2020 only, but add a late payment charge for those who do not make payment by the due date. Property owners who paid their easement assessment in 2017 will only receive an invoice for 2020. All others will receive an invoice for 2017 and 2020. The 2020 basic membership fee, formerly called the assessment, is \$115 and is available for members who agree to waive certain rights and want to pay only the minimum required. The 2020 full membership fee of \$315 will include the required \$115 assessment for 2020. The senior discount is \$285, also includes the required \$115. Payment in full is due by March 31; after April 1, all delinquent accounts will be assessed a \$100 late payment charge. All other payment terms and collection policies will remain.

As mentioned in prior editions of *News & Views* the membership fee runs with each property. Meaning that if you purchase a full membership at any level it covers only family members living at the property.

Membership runs from April 1st of the current year through March 31st of the following year. The board is considering changing it to the calendar year going forward. This will require addressing all of the possible scenarios related to doing so. This includes how the budget and billing would occur.

The Board has always worked to keep fees as low as possible. We are still the lowest in the area, but that comes with a price. Prior to the litigation, each year we do our budget on what funding we

hope we will get. We add in projects and improvements that we either need to or we would love to get done. We can't always budget for emergency reserve funds, which means if we don't make budget many of the projects are scrapped and put in the following years' budget. Yes, absolutely there are times where we have no choice but to do an unforeseen repair. One that immediately comes to mind is the air conditioning at the clubhouse that failed. When that happens, we must make budget cuts in other areas. Worst case scenario we draw from limited reserve monies.

One of the wild cards to the budget is insurance. Each year our insurance can fluctuate dramatically. We are limited on who we can use as a carrier because many won't even speak to us once we mention the dam and dikes. Since there were multiple dam breaches in the state about 10 years ago fees have been in major flux. As we stated at the meeting, once we have completed a year with confirmed mandatory payments, we will be able to better predict our receipts and budget accurately going forward.

We are pleased with our relationship with Aquatic Technology, the vendor we have to care for the water. Mary Purzcyki was instrumental in selecting them when she served on the board as water quality director. Many of the lakes in the area also use them. Aquatic is on the lake from roughly mid-April through September. We don't treat the water after Labor Day, simply because of costs. Garden State Labs performs water sampling weekly during the summer months in accordance with state regulations. Since 1998 I'm proud to say we only had a water quality issue once. Remember it was just last year that Lake Hopatcong was, for all intents and purposes, closed all last summer because of water quality concerns.

In closing I will stand by the statement made back in 2016/2017 by the committee investigating this process that everything will be in a state of flux for 3-5 years until we see where we are. I know there are a lot of questions and we need to work together to get answers.

The membership committee under direction of our financial secretary Dan Nazzaro will be presenting their final recommendation at the February Board meeting for the mechanics of distributing the membership badges and supplies.



# BE A PART OF THE OPEN HOUSE TEAM!




## Please don't kill us with bread!

# FISHING CLUB

I hope everyone had safe and joyous holidays.

Before we know it, the first fishing club event for 2020 will be here, the annual trout stocking event. Opening day for New Jersey's 2020 trout season is April 11th at 8am, so, the trout stocking event will be April 4th. The stocking truck can show up anytime between 9am and 10am. On average the truck arrives 9:30am. Someone will be at the boathouse by 8am. We strongly urge the young anglers to come out. We really need their assistance to stock the trout. Parents of young anglers don't need to worry if you think they don't enough energy to stock the trout, the fishing club will supply them plenty of hot chocolate and donuts. That should give them plenty of energy, lol. There will also be coffee. Coffee, hot chocolate and donuts are compliments of the fishing club.

We hope we can stock close to the amount of trout we stocked last year. Hopefully, the amount will be in the area of 350 to 370 with an average size of 13 inches. We would also like to stock at least 5 trout that will be 17 inches plus. We like to associate a prize to the large fish. If anyone would like to donate a prize and or purchase a large trout, it would be greatly appreciated. If you would like to donate, please contact the fishing club at lakeparfishingclub@gmail.com. There is also a link to the email on the fishing clubs page on the lake's website. If you make a donation of at least \$25, you automatically are a fishing club member for 2020. The cost to join the club is, \$8 for a single person between ages 16 and 69. Under 16 is free but must register with the fishing club. Family membership is \$15 and age 70+ is \$10 for life.

Just a reminder that you are required to have a 2020 New Jersey freshwater fishing license to fish Lake Parsippany if you aged 16 to 69. You will also need a trout stamp if you plan on possessing trout. This is a New Jersey regulation not an LPPOA regulation. All New Jersey freshwater angling regulations must be followed at minimum. The LPPOA can strengthen New Jersey freshwater angling regulation but we cannot weaken them. Please refer to the fishing club's website

page for LPPOA regulations. At Lake Parsippany, our rule is that, Largemouth Bass, Crappie's and Channel Catfish are catch and release. It is every angler's responsibility to know the angling regulations of New Jersey and the LPPOA. Fishing licenses can be purchased online. The advantage to purchasing online is, you can print more than one and if you do lose your license, you can just visit the fish and game website and print more.

Now is a good time to get your fishing equipment ready. Change the line on your reels, add some oil or grease if needed. Check the eyes on your fishing rod for cracks. Easy way to check eyes is to use a Q-tip and go around each eye as if you were cleaning them. The cotton should catch on any burr's or cracks. Check your terminal tackle such as, hooks, weights and bobbers. If you need assistance with fishing reel repair, I can lend a hand fixing the reel/s or I can show you how to fix the reel or I can just show you how to perform maintenance on your reels. Just contact me through the club's email.

Another reminder, fishing never closes. Just because its winter doesn't mean that you can't fish. If you have a current New Jersey freshwater fishing license, you can fish. Please check the New Jersey angling regulation if you plan on keeping fish. Some fish species have closed dates when you cannot keep them and different creel limits.

Hope your next cast is one you will never forget.

***Remember it's not always about catching fish, it's about being outdoors and enjoying the adventure with your family and friends.***


